FY 2009-2013 TRANSPORTATION IMPROVEMENT PROGRAM
AMENDMENT 1

This amendment adds roadway reconstruction projects sponsored by the City of Dalton and revises available funding for a roadway reconstruction project sponsored by the City of Coeur d'Alene.

Also, a project that was removed from the program in 2008 was inadvertently carried over into KMPO's TIP. This amendment administratively deletes it.

Finally, several administrative funding adjustments were made by ITD prior to federal adoption of the Statewide Transportation Improvement Program (STIP). This amendment mirrors those adjustments in order for KMPO's TIP to be consistent with the STIP.
