Jeanette,

I have reviewed the Idaho Transportation Department's (ITD) request to amend the 2015-2020 KMPO Transportation Improvement Program(TIP) to include the above referenced project. Based on my review, this amendment should be considered and administrative modification to the 2015-2020 KMPO TIP for the following reasons:

1. The KMPO Board recently adopted the KMPO 2016-2021 Transportation Improvement Program(TIP); which included the U.S. 95 Cougar CR to Blackwell Slough, Kootenai County project KN 13854, and therefore updates KMPO Board actions taken on the KMPO 2015-2021 TIP;
2. The 2016-2021 TIP was publicly advertised for comment prior its adoption by the KMPO Board and has therefore met the public involvement requirements for inclusion to the TIP; including it in a prior year TIP for obligation purposes does not change the intent to obligate funds for PE/PC in Fiscal Year 2016;
3. The design, concept and scope of the project has not changed since the KMPO Board adopted the 2016-2021 TIP;
4. A Key Number change is not a material change to the project itself;
5. The decrease in requested funding for FY 2016 for Development funding (+/- 7.5%) does not materially impact the activity PE/PC nor does it appear to adversely impact the lifetime cost of the project,
