**KMPO 2018-2022 Transportation Improvement Program Amendment #6, Administrative Amendment to Split an existing project into three (3) Key Numbers to facilitate Bidding and project scheduling with construction funding in FY 2019**

KMPO is administratively amending the 2018-2022 Transportation Improvement Program to reflect a request to create three Key Numbers to facilitate the projects phasing, bidding and scheduling. The project is currently within the existing 2018-2022 Transportation Improvement Program and does not impact fiscal constraint, nor does it modify the existing scope of the total project.
