SUBJECT: 2018-2022 KMPO TIP Amendment #14 Modifications to existing projects to increase funding levels for

FY 2019 activities with key numbers 19452 and 20120

KMPO 2018-2022 Transportation Improvement Program Amendment #14, Modify existing projects to consolidate scope and budget and increase funding levels for right of way and land puchase

KMPO is administratively amending the 2018-2022 Transportation Improvement Program to reflect FY 2019 increases to phases of a project already within the approved program from funds being consolidated from another project within the same project area. KN 20120 SH 41, Lancaster Rd to Boekel Road will receive additional funding from KN 19471, which will be removed from the current program. The updated project will also include the project scope of work. This is being accomplished by adding into the FY 2019 program year funding for RW in the amount of \$75,000 and LP \$200,000 from KN 19471 into KN 20120 . The project and funding is currently within the existing 2018-2022 Transportation Improvement Program and does not impact fiscal constraint, nor does it modify the existing scope of the project of the combined projects.
