SUBJECT: 2019-2025 KMPO TIP Amendment #4 Increasing PC Funding for KN 12315 Kidd Island Road \$148,000 and

Incorporate KN 12977 Local, UPRR RRX Closures Scope of Work and Funding \$232,000 into KN 20098 SH-41,

Prairie Ave to Lancaster Rd.

KMPO 2019-2025 Transportation Improvement Program Amendment #4; Kidd Island Road Project (KN 12315), increasing PC Funding in the amount of \$148,000 for consultant services; Incorporate Local, UPRR RRX Closures (KN12977) Scope of Work and Funding in the amount of \$232,000 into the SH-41, Prairie Ave to Lancaster Rd Project, (KN 20098).

KMPO is administratively amending the 2019-2025 Transportation Improvement Program to increase PC (Consultant Services) in the amount of \$148,000 in contract engineering to cover project related engineering costs. In addition ITD has requested rail road crossing closure activity associated with the UPRR rail spur that crosses SH-41, to be incorporated into the larger SH-41 widening project from Prairie Avenue to Lancaster Road. The scope and budget will remain the same. ITD will certify that funds are currently available in order to obligate the additional funds to these projects from the FY 2019 program year.
