KMPO 2019-2025 Transportation Improvement Program Amendment #25 introduces Eight new projects, recently approved by the ITD Board as part of the 2020-2026 Transportation Improvement Program adoption. Amendment of these projects will allow ITD to begin early preliminary engineering as well as come heavy maintenance/repairs on Interstate 90. These projects are being administratively amended into the 2019-2025 TIP, they have been through the full public involvement process for the 2020-2026 STIP/TIP; therefore have fulfilled their public involvement requirement pursuant to Title 23 prior to approval by the ITD Board. ITD certifies Federal program funds are available to support the funding identified within this amendment.
