SUBJECT: 2020-2026 KMPO TIP Amendment #4 Modifying Scope and Budget between multiple companion projects to realign programmed

funds to match scope, fund eligibility, and improve construction contract administration.

The Kootenai Metropolitan Planning Organization (KMPO) received a request from the Idaho Transportation Department (ITD) to modify companion projects contained with the 2020 TIP to align projects to be more streamlined and efficient in their development and construction.

Improvements include a 4-lane divided roadway, upgrading the signal at Hayden Ave, installing a new signal at Wyoming Ave, upgrading a RR crossing signal, intersection turn bays and illumination, with a shared-use path on one side of the highway. Amend #4 additional 8.3 million to Construction from KN 2120, changes MP to include mileage contained in KN 20120, Offset for Const. Cost Estimate 3.5 Million from State.

Also, design safety improvements at the intersection of Hwy 41 and Lancaster. Amend #4 transfers construction funding and Mileage to KN 20098 to facilitate bidding and construction management

Remove the existing at grade intersection at US-95 and Garwood Rd. Realign Garwood Road and construct a two new grade separation over US-95 and the UPRR. Construct new frontage roads to connect Garwood Rd to the SH-53 interchange in order to remove all access points to US-95. Project is funded with Grant Anticipation Revenue Vehicle bonds until repaid via debt service using federal funds. Balancing Fund Transfers between Prior Year Project KN 20794 Companion Project U.S. 95 Jct SH-53 and UP Bridge replacement

These projects will address current safety and capacity deficiencies and accommodate increased recreational use by providing a wider road with roadside safety measures and shared use path adjacent to but separated from the highway. This improvements will assist ITD and KMPO in continuing to surpass the Statewide Safety performance goals in the overall reduction and severity of crashes, as well as the reduction crashes for pedestrian and bicycle users.

As an Administrative Amendment as the design, concept and scope of the companion projects have not changed and the reallocation of funds between programmed companion projects and prior year projects has been balanced. ITD has stipulated they have sufficient funds through the Statewide balance to offset the anticipated 3.5 million difference between the current cost estimate and the programmed funds for KN 20098.

The Kootenai Metropolitan Planning Organization, approves Amendment #4 for projects as identified above effective January 14, 2020.
