Amendment #10 Adds \$5k to PE for the project. Amendment #10 Increases Utilities (CN)532,010 and increases PE \$25,000 to the project</mark>

This amendment does not affect the projects impact on performance measures, and is supported by ITD from offsets from other projects (KN 13414 \$244,901, KN19498 \$166,611, and KN 19664 \$145,498). ITD certifies they have sufficient funds to program to support this Administrative Amendment through these offsets.
