The regular meeting of the Kootenai Metropolitan Planning Organization Policy Board held via Zoom video conferencing was called to order by Chair Jim Kackman at 1:30 p.m.

#### 2. Changes to the Agenda and Declarations of Conflicts of Interest – Action Item

Mr. Rod Twete moved to approve the agenda. Vice Chair Lynn Borders seconded the motion which passed unanimously.

#### 5. KCATT Recap & Recommendations – Kevin Howard

a. Recap of Activities – September/October 2020

KCATT Chair Kevin Howard reported KCATT had met in September and October. The committee reported project updates, discussed the regional funding effort, and the Huetter Corridor realignment. KCATT recommended the KMPO Board approve the 2021 KMPO Board and KCATT Meeting Dates & Locations calendar.

Mr. Miles discussed Administrative Amendments 19-22; no action was required. Mr. Austin commented on Administration Amendment #19 and East Side Highway District receiving the \$1.5 million for the Fernan Gulch/Fernan Hill Road project; the District is grateful for the funding.

#### 7. Other Business

a. Regional Funding Effort Update

Mr. Miles provided a recap of the Kootenai County Local Option Vehicle Registration Fee ballot measure results. With 33.6% of the votes, the measure fell short of the 50%-plus-one required to pass; a map showing the percentage of votes by precinct was reviewed. Precincts with voters that would have directly benefited from the proposed projects appeared to have a higher approval rating; only one precinct had an approval rating greater than 50%. Mr. Miles stated the campaign effort was led by the Coeur d'Alene and Post Falls Chambers of Commerce and

driven by the business community. He thanked Steve Wilson, campaign chair, Len Crosby, campaign treasurer, and Candace Godwin, campaign manager, for their work.

A discussion related to issues surrounding the ballot measure included legislation, a reduced fee for senior citizens, a local gas tax, modifying the proposed countywide vehicle registration fee to areas that would receive the greatest benefit, and an advisory ballot measure asking voters to select six of the 12 projects. Mr. Miles said he believed there was a general lack of understanding on how transportation is funded and distributed throughout the state; residents suggested a number of alternative funding solutions including gas tax, tolls, and impact fees. Overall, he felt there was support for transportation. In moving forward, Mr. Miles said he felt it was important for KMPO to work with local jurisdictions and hold meetings for the community and business groups to discuss transportation challenges and funding. He suggested spending the next year researching options and addressing the legislature during the 2022 session.

Mr. Werner requested the map showing the percentage votes by precinct be sent out as he would like to share it with their highway district board.

Mr. Miles said it was important to note that the ballot measure was only expected to fund 30% of the overall cost of the projects. There is a need to discuss transportation with area legislators as their support is needed. He believed the legislators would be looking at a statewide gas tax adjustment in the 2021 session; this area would receive approximately 2.7%.

b. Health Corridor Study Update

Ms. Ali Marienau noted the Coeur d'Alene Health Corridor Study consultant, DOWL, would be giving a presentation and introduced the project manager, David Simmons. Mr. Simmons discussed the project study area, status of the scope (completed, current, and future tasks), and the project schedule. He commented on the existing data, conditions, and analysis of 27 intersections; the most significant recommendation was to review signal timing. As there was no actual traffic analysis included in the Health Corridor Master Plan, they will be looking at what is in the plan and how it performs. The location of the corridor, accessibility at I-90 and US-95, and background congestion were discussed. An implementation plan for the transportation infrastructure elements and a summary report will be developed. As they move into the analysis of future conditions, they expect to hold a series of meetings. Outreach activities were noted. The Study is expected to be completed in the April 2021 timeframe.

c. December Board Election of Officers - Chair

Chair Kackman noted the election of a new chair/vice chair would be done during the December KMPO Board meeting.

  - a. Kootenai County Transit Report Amber Conklin/Chad Ingle

Ms. Amber Conklin reported their ridership numbers have continued to increase since the pandemic. The Paratransit and Ring-a-Ride programs have seen a rapid increase with approximately 100 rides per day; they continue to receive numerous applications. Ms. Conklin noted the fixed route report showed a slight decrease in ridership numbers but said that was likely due to them changing over to their new software, Passio Technologies.

b. Coeur d' Alene Tribe Rural Transit Report – Alan Eirls

Ms. Conklin stated Mr. Alan Eirls had asked her to address the Board on his behalf as he was unable to attend the meeting; Mr. Eirls did not have any significant updates to report.

9. Director's Report (written report included in Board packet)

Mr. Miles noted the Director's Report was included in the Board packet. The annual audit is underway and expected to be complete by mid-December.
