1. Call to Order - Lynn Borders, Chair

The regular meeting of the Kootenai Metropolitan Planning Organization Policy Board was called to order by Chair Lynn Borders at 1:30 p.m.

2. Changes to the Agenda and Declarations of Conflicts of Interest - Action Item

There were no changes to the agenda or conflicts of interest declared.

3. Approval of August 12, 2021 Meeting Minutes - Action Item

Vice Chair Rod Twete moved to approve the August 12, 2021 meeting minutes. Ms. Jeri DeLange seconded the motion which passed unanimously.

4. Public Comments (limited to non-agenda items 3 minutes)

There were no public comments.

5. KCATT Recap & Recommendations - Ben Weymouth

a. Recap of Activities - August 2021

KCATT Chair Chris Bosley provided a recap of the August committee meeting, noting regional projects – ITD bridge repairs and a Request for Proposals (RFP) on the I-90 widening project. Several jurisdictions are facing project delays due material shortages; the pandemic, severe

winter storm in Texas last February, and Hurricane Ida were cited as events impacting supply chains.

b. DRAFT FY 2022 Unified Planning Work Program (UPWP) Recommendation – **Action** Item

Mr. Bosley noted KCATT had reviewed and recommended approval of the FY 2022 Unified Planning Work Program (UPWP); the matter is an action item before the Board.

Mr. Miles noted he had met with Kootenai County staff to discuss and update the public transportation narrative. Transit planning funds were also updated to include previously programmed 5307 funds in the amount of \$150,000; the amount included local match.

Jim Kackman moved to approve the FY 2022 Unified Planning Work Program (UPWP). Mr. Darrell Rickard seconded the motion which passed unanimously.

c. DRAFT FY 2022-2028 Transportation Improvement Program (TIP) – Recommendation to Approve

Mr. Bosley explained that Mr. Miles would be addressing the FY 2022-2028 Transportation Improvement Program (TIP); Chair Borders noted the matter was listed as agenda item 7.a.

6. Administrative Matters

a. August 2021 KMPO Expenditures & Financial Report – Action Item

Jim Kackman moved to approve the expenditures for August 2021. Mr. Darrell Rickard seconded the motion which passed unanimously.

7. Other Business

a. DRAFT FY 2022-2028 Transportation Improvement Program (TIP) Recommendation –
 Action Item

Chair Borders noted KCATT recommended approval of the draft FY 2022-2028 TIP.

i. Offer of Public Comments on the 2022-2028 Transportation Improvement Program (TIP)

Noting the comment period had previously closed, Chair Borders opened the matter for public comment.

ii. Close of Public Comments

Chair Borders closed the public comment period as no public comments were offered.

iii. Action on the 2022-2028 Transportation Improvement Program (TIP)

Mr. Miles noted the FY 2022-2028 TIP was advertised in the Coeur d'Alene Press on July 28th and August 7th. A public open house was held on August 12th from 4:30 – 7:00 p.m.; there were no attendees. The TIP included nearly \$389 million worth of projects. Mr. Miles explained the document was dynamic, noting the FY 2021-2027 TIP had seen 17 amendments thus far.

Ms. Jeri DeLange moved to approve the FY 2022-2028 Transportation Improvement Program (TIP). Vice Chair Rod Twete seconded the motion which passed unanimously.

8. Public Transportation (Informational Items Provided to KMPO)

KMPO is not the Designated Recipient of FTA Funding for the provision of transit Service in Kootenai County. a. Kootenai County Transit Report – Kootenai County Public Transportation Staff

Mr. Chad Ingle reviewed their monthly report and updates; fixed-route/demand response ridership, on-time performance, vehicle and revenue miles, hours, and trips were noted. An update on the Integrated Mobility Innovation (IMI) project was provided; a demonstration will be given to the KMPO Board and KCATT next month. Current projects include bus stop improvements, the Riverstone Transit Center Phase 2, the public transportation website, and next bus procurement phase. The Strategic Service and ADA Transition Plans are being updated. The Board was asked to provide feedback on the level of reporting provided and if they would like to see any changes.

Mr. Miles noted the KMPO Board was a policy board for public transportation. He provided background on Kootenai County's involvement noting local jurisdictions receive the urban transit funding but have contracted with the county to provide the service. As part of the arrangement, county staff attend the monthly Board meetings to report to local jurisdictions and provide an opportunity for questions and feedback. He encouraged the conversation between the Board and county staff citing local jurisdictions as the designated recipient of the transit funds.

Mr. Kackman said he felt the reports provided the necessary and desired information, noting the Board had the opportunity to ask questions and county staff was responsive.

Mr. Tyler commented on a problematic bus stop in the Post Falls Highway District. Mr. Ingle explained that they were working with the consultant to get the Huetter Road/Seltice Way bus stop finalized; he hoped they would be moving the stop soon.

b. Coeur d' Alene Tribe Rural Transit Report – Alan Eirls

Mr. Eirls was not present; no rural transit report was provided.

9. Director's Report (written report included in Board packet)

Mr. Miles said, during the 2022-2028 TIP process, he had received several inquiries related to the funding of projects. He commented on the proposed \$3.5 trillion infrastructure package, noting only 40% was related to infrastructure; if not passed, a continuing resolution is expected as the FAST Act will expire on September 30th. A substantial increase to the Surface Transportation Block Grant program (STBG) has resulted in the State of Idaho receiving an additional \$65 million a year. Mr. Miles discussed the 2020 Census and noted Ada, Canyon, and Kootenai Counties represented 49% of the state's population but receives only 2.3% of the federal aid funding under ITD's current distribution formula; KMPO receives \$1.4 million a year. He commented on the legislature's recent funding of projects through additional sales tax and noted the funds were committed for the next 20-30 years. The ITD Board has directed their Subcommittee on Policies to discuss the distribution formula related to funding under their jurisdiction. Mr. Miles commented on changes at the Local Highway Technical Assistance Council (LHTAC) and anticipated changes due to Director Ness' upcoming retirement.

Mr. Jim Kackman moved to adjourn the September 9, 2021, KMPO Board meeting. Vice Chair Rod Twete seconded the motion which passed unanimously.
