SUBJECT: 2023-2029 KMPO TIP **Amendment #20** Requests by the Idaho Transportation Department on current **projects KN12310, KN19955, KN23028**

The Local Highway Technical Assistance Council (LHTAC) is requesting modifications on **KN 12310 Ramsey Road Extension** increasing Right of Way in the amount of \$67,000 (LP); **KN19955 Chase Rd BNSF Crossing** increasing Engineering and Design (in the amount of \$310,000 (PE,PL); and **KN23028 Prairie Avenue, Meyer Rd to SH-41** in the amount of 400,000 for RW (LP). Funding to support this amendment is provided through the Statewide Urban Balancing Committee.

The 2023-2029 Transportation Improvement Program **Amendment #20** provides for the amendment by Administrative Modification where the does not materially change the design, concept, or scope of the original project, and conforms to previously approved existing plans and programs. These projects have been through the required and concluded public involvement processes and included in the existing TIP. ITD and LHTAC certify by their submission to KMPO for an amendment to the current 2023 transportation program year, that funds are available from existing resources. Based on the representation by ITD on Tuesday August 29, 2023, the Kootenai Metropolitan Planning Organization approves **Amendment #20 effective August 29, 2023**.
