SUBJECT: 2023-2029 KMPO TIP Amendment #25 Request by ITD on KN 21935 to convert from Advance Construction CN to Federal Funding CN

The Idaho Transportation Department is requesting an amendment to the 2023 Transportation Improvement Program (TIP). This Amendment converts State Advance Construction funding for Construction (CN) to for **KN 21935 I- 90, CD'A RV BR EBL & WBL, KOOTENAI CO.** This action converts AC for CN from FY24 (\$5,506k) and FY25 (\$10,600k) per FY23 end-of-year OA.

This project will replace the I-90 Coeur d'Alene River structures. The existing structure currently has many deficiencies that include: excessive spalls and cracks, exposed reinforcement throughout structural components; along with a substandard vertical clearance. The new, wider bridge will be constructed on a variable raised profile that meets current standards and the minimum 17.0 feet vertical clearance over I-90. The project is located on I-90 between mile points 39.7 and 40.1. Amend #12 Amendment #19 Advance project from FY 2025 to FY 2023 using un-programmed State Funds.
