# 3. Approval of May 21st, 2024 Meeting Minutes - Action Item

Kevin Howard, Worley Highway District, had an amendment to the June minutes. He commented that the location of a project was identified as "Mica Bay Road", where it should have been recorded as "Mica Bay".

David Callahan motioned to approve the June 2024 KCATT meeting minutes, as corrected. Robert Palus seconded the motion, which passed unanimously.

### 4. Public Comments (limited to 3 minutes per person)

There were no public comments provided.

### 5. Member Project, Transit & Utility Updates

Rob Beachler, Idaho Transportation Department, reported on current ITD projects. The I-90/SH 41 interchange project has utility relocation work ongoing at SH 41 and Mullan Ave., as well as the construction of water and stormwater infrastructure. The pedestrian underpass is in place; the westbound median deck is scheduled for completion mid-July, with traffic to switch over by October. For the SH-53 (Latah St. to mile post 9.3), project utility relocation work is ongoing with a pause for the 4<sup>th</sup> of July holiday. Work on the westbound lanes' stormwater system and sub-grade work to begin mid-July. The I-90/Coeur d'Alene River bridge replacement project is to begin on June 26<sup>th</sup>. This will include some temporary bridge work that will close both fast lanes; plans to

install the concrete barrier after the 4<sup>th</sup> of July are in place. The SH 53 and Pleasant View Rd. Interchange will go out to advertisement July 2<sup>nd</sup>; it will be open for 5 weeks. I-90, Wolf Lodge to Cedars maintenance site (mile post 23 to 32.4), will go out to advertisement on July 9<sup>th</sup>. Mr. Beachler reported that the draft ITIP FY 25-31 public comment period starts July 1<sup>st</sup>; comments can be made at itd.idaho.gov/funding. He stated that there would be public meetings held for the Rathdrum Prairie PEL Study the evening of June 25<sup>th</sup>, from 5 to 7:30 PM, at KTEC on Lancaster Rd. and June 26<sup>th</sup>, 6 to 8:30 PM at the Coeur d'Alene Shriners club on Lancaster Rd. Mr. Marvin Fenn gave an update that an issue came up on the seal coat project up SH-54 by Silverwood. In the process of trying to smooth out the outside lanes, some water damage occurred that the seal coat can't fix; ITD is currently working through various repair options for a solution.

Eric Shanley, Lakes Highway District, reported the work on Diagonal Road is wrapping for the year. Avista is expected to move power poles in the next month; a full reconstruction project for this section will go out to bid next spring. Lakes Highway District's pavement markings are done; the district is moving on to chip seal and striping projects. Chip sealing is set to start July 8<sup>th</sup> and take three weeks for 25 miles to be completed. The Garwood operations center is ongoing; all structures are up, and the project should wrap up in October. Lakes Highway District has a couple redesign projects ongoing: Old HW 95 and the Union Pacific railroad bridge realignment project is in design phase; Lancaster Rd./Huetter Rd. roundabout project, in partnership with Post Falls Highway District, is ready to go out to bid for next year. Lakes Highway District has been working on applying for grant funds for the Brunner Rd./BNSF grade separation project; preliminary design and right of way acquisitions are underway.

David Callahan, Kootenai County, thanked the highway districts for sending representation to a meeting with engineers to discuss county road standards. He felt the meeting was meaningful and provided a space for questions to move forward.

Kevin Jump, City of Rathdrum, reported on the city's street rehab project; bids will be opened today. SH-53 has reopened at Mill Street.

Chris Bosley, City of Coeur d'Alene, reported that there will be significant road work in July. The mill and inlay on Atlas Rd. was finished and additional mill and inlays are set to begin on Appleway Ave., from Ramsey Rd. to Howard St., and on Ramsey Rd. south of Kathleen Ave. A chip seal is set for Northwest Blvd., from Riverstone Dr. to Government Way. He reported they will be chip sealing Riverstone area to Lacrosse Ave. He stated they are trying a new technique to chip seal bike lanes; the city encourages people to use the lanes and provide any feedback on performance. The city is also doing mill and inlay on Sherman Ave. from Four Corners to 8<sup>th</sup> Street; most work will occur at night, with utility adjustment work happening during the day. The brick intersection at 4<sup>th</sup> St. and Boise Ave. is being replaced. He reported on the work underway for the RRFB project on Hanley Ave. at two locations.

Robert Palus, City of Post Falls, reported they are working on chip seal and restriping efforts. 12<sup>th</sup> Ave. is under construction; the city is extending a dual force main from SH 41 to Sugar Maple Trail (over a half mile in length and will take most the summer to complete). Post Falls has two roundabouts they are completing: at 4<sup>th</sup> Ave. and Idaho Rd., and at Harvest and Fennacus Ln. In coordination with Post Falls Highway District's Spokane River Bridge project, the city is closing a portion of Spokane Street and diverting traffic from the area. This project is slated to take most of July and August to complete. The city is finalizing some details on the Chase Road/BNSF rail crossing project with BNSF.

Kevin Howard, Worley Highway District, reported the Cougar Gulch Road improvement project is underway from Miller Road intersection for .6 miles. The Rockford Bay Road and Loff's Bay Road intersection has the notice to proceed announcement out. Rockford Bay Road/Bellgrove Creek crossing final design is completed and easement acquisition is beginning. Lake Creek area fish crossing project is in partnership with Coeur d'Alene Tribe. Worley Highway District has installed one overflow crossing at Elder Road, with two more to be installed this year and two more next year: at Idaho Road, off Elder Road, and Weller Road at Bozard Creek. The Rockford Bay Road

participation project build up was completed last fall. The first two chip seal applications were completed in early June, the final seal will be done mid-July. The Greensferry R. guardrail project has a design final review on June 25<sup>th</sup>.

Michael Lenz, Post Falls Highway District, reported that the Spokane Street Bridge Project is continuing deck work; the contractor will soon move to in-water repairs for the bridge. Construction on 8<sup>th</sup> Ave. for mailbox pull outs and skim patching is ongoing. Harbor Drive/Riverview Dr. realignment project is 90% complete; the contractor needs to finalize the chip seal, and then they will work on punch list final items. He reported the district will start 38 miles of chips seals on July 8, which will be about 3 weeks of work. The Prairie Ave. 5-lane project will have right of way plans finalized June 25<sup>th</sup>.

### 6. Planning and Programming Updates

### a. 2024 Federal Functional Classification Map Update- Action Item

Ali Marienau, KMPO, presented on the functional classification map update. A visual of the map was included in the meeting packet and was referenced during the discussion. A draft of this map was presented in April; some minor adjustments have been made since then. The map now represents the urban area for the city of Rathdrum, due to the adjusted urban area boundary that was approved by the KMPO Board two weeks ago. The adjustment was the change to an urban classification from rural classification. As discussed previously, the percentages of total mileage all fall within the recommendation for total mileage per classification, except for minor collectors, due to the additional forest service roads. Ms. Marienau mentioned for the Urban map the class was adjusted on several different facilities, either to principal arterial or minor arterial, as well as adding additional collectors, particularly in areas where there have been developments over the last 10 years. Ms. Marienau then discussed the rural map, noting that Lakes Highway District area had several roads up classed as well. Ms. Marienau asked KCATT for a recommendation to the KMPO Board to approve the new Federal Functional Map update. Mr. Beachler, ITD, asked to table the recommendation so he could have more time to review in depth. He mentioned that this update done my Ms. Marienau is ahead of schedule, and ITD is till reviewing other items prior to this. Mr. Shanley asked KMPO to define the role ITD plays in this process. Mr. Miles, KMPO, explained that it's the responsibility of KMPO to put together the functional classification system map and have the Board approve it, before it's included in the state wide functional classification system. ITD has authority to review the map before it goes to the Federal Highway Administration. In short, ITD has a review role, rather than decision making. Since there is time before the map needs to be submitted, Ms. Marienau agreed to allow more review time and move the decision to the July KCATT meeting.

# Mr. Palus motioned to table the decision, Mr. Shanley seconded, which passed unanimously.

Mr. Miles mentioned that a question had come up about some of the bridge projects that are state funded only are not on the ITIP. Federal requirements state that a regionally significant project, regardless of funding type or project sponsor, must be in the ITIP, to provide a bigger picture of what's going on in the area. Mr. Miles had some conversations with headquarters at ITD and also Federal Highways about how to reconcile some of these bridges and other local projects that are regionally significant but not federally funded. There will be a discussion in Boise about making sure the whole picture is shown, not only the federal aid program.

### 7. Idaho Transportation Board Update

Mr. Beachler reported that the ITD board meeting and workshop that will be held in District 1 will be July 23 at the Best Western in Coeur d'Alene. Mr. Miles and Mr. Fenn both made comments that the ITD Board would appreciate the KCATT members attendance and participation in the conversations had during the board meeting. Mr. Fenn reported that one of the main areas of concern for the ITD board in District 1 is to look at truck parking and the port of entry logistics.

### 8. <u>Current Business</u>

No current business was addressed during the meeting.

# 9. <u>Upcoming KMPO Board Items</u>

The updated MOU with ITD is going before the board in July for approval. KMPO has the FY 25 draft budget to present to the board, as well.

SUBJECT: 2024 Federal Functional Classification Map Update

### **Background:**

The functional classification of roadways helps planners and engineers identify what role a roadway serves in moving vehicles throughout the transportation network. The Federal Functional Classification (FFC) Map, approved by FHWA, plays a role in determining a roadway's eligibility for federal-aid programs, guides a roadway's design elements, and is an increasingly important consideration for project prioritization and performance-based planning.

After the decennial Census, states and MPOs revisit the functional classifications to make appropriate modifications to account for adjusted urban area boundaries but also to address changes in the intensity and distribution of land development patterns, the addition of new roadway facilities, and the change in facility function. While changes can be made to the federal functional classification between Census years on a case-by-case basis, the full review and revision of the adopted FFC map allows for agencies to address the system as a whole and make adjustments based on how classifications interact as parts of the overall network.

FHWA breaks down functional classification into urban and rural facilities and then into the following hierarchy, top to bottom: interstates; freeways and expressways; principle arterials; minor arterials; major and minor collectors; and local roads. This hierarchy is based on the concepts of mobility versus access. While interstates and freeways/expressways are only a small percentage of total roadways, with the least amount of access, they serve the largest number of and longest distance trips. Conversely, local roads make up the largest percentage of roadways and provide the most access, but primarily only serve small local populations. After all arterial and collector roads are classified, remaining roadways are classified as local by default. Local roads and rural minor collectors are not eligible for federal-aid funding programs.

The designation of a roadway's classification is as much of an art as it is a science. FHWA provides guidance through the *Highway Functional Classification Concepts, Criteria and Procedures, 2023 edition* providing recommendations of what characteristics to consider – such as speed, number of access points, route spacing, and intensity of usage (e.g AADT),

number of travel lanes – but classification is also dependent on surrounding land use and requires local knowledge of facilities and community interactions.

### **Overview:**

KMPO staff consulted each KCATT agency to review the existing functional classifications of their roadways and identify changes that could be made to better reflect current function and to address facility and land use changes that have occurred since the last update. A new map was drafted with the incorporated changes and sent back to each agency for review. A further round of adjustments was made based on feedback. The maps in attachments A and B reflect the modifications KCATT agencies have requested; attachment C lists all roadway changes.

The breakdown of total miles by classification is as follows:

Roadways identified as future facilities are not included in the totals. All classifications met FHWA's guidelines for total mileage per classification, except for Rural Minor Collectors; this is due to the inclusion of several forest service roads (approximately 87 total miles) that connect into Shoshone County and were previously included on KMPO's FFC map. KMPO believes the inclusion of these sections are under the purview of the state, as they are not under the authority of the local agencies; it will be ITD's decision if those routes remain on the map.


KMPO staff recommends KCATT approve the urban and rural FFC maps and provide a recommendation for adoption by the KMPO Board.
