### 3. Approval of September 23rd, 2025 Meeting Minutes – Action Item

Chairman Robert Palus asked for a motion to approve the minutes as presented.

**Mr. Eric Shanley motioned to approve the September 2025 KCATT meeting minutes as presented. Mr. Kevin Howard seconded the motion, which passed unanimously.**

### 4. Public Comments (limited to 3 minutes per person)

There were no public comments made.

### 5. Member Project, Transit & Utility Updates

Mr. Robert Beachler, ITD, reported

I-90/SH-41 Interchange project has 4 of the 4 SPUI lanes operational, two lanes in each direction. Upcoming work includes paving on I-90 mainline to shift traffic over and allow the demolition of the temporary bridges. The contractor has plans to work through the winter.

I-90 (Wolf Lodge to Cedars maintenance site, Fourth of July interchange) Lighting work and paving of the ramps is completed, illuminating the interchange as a safety improvement. ITD will add lighting to some of the day used areas as well. Plans for a PTZ camera to better monitor the weather are in place. The rest of the project is shut down for the year.

Coeur d'Alene River bridges have construction efforts pushing forward on the North side. The contractors are working hard to make up for time lost during the strike. The plan is to move one lane of traffic to the new eastbound bridge by Wednesday, and continue guardrail work on the east and west ends of the bridge. For the winter, they will remove the striping as they are not functional with the lanes of travel.

I-90, SH-41 to US 95 Widening Project- on the west package (SH-41 interchange, heading east) crews are doing clearing and grubbing, work on the MSE walls (which includes pile driving), some fill removal, and some additional tree clearing in the port of entry area. The project also has utility relocations going on, including at Huetter Road, in preparation for the new MSE walls for the bridge replacement on the east package. Utility relocations will include the AT&T intercontinental line.

For the Pleasant View/SH-53 interchange, bridge work is completed for the season. The contractor will continue to do dirt work while the weather holds. The interchange will open next summer, with full contract completion scheduled for April 2027. Post Falls Highway District is coordinating on curb work along that route.

SH-54, SH-41 to Greystone Road has completed for the first two miles of the corridor. There is one final lift to be done on that. The speed limits are set at 45, through the season, but might be evaluated to see if that can be raised. Utilities are relocating through the rest of the corridor.

US-95 I-90 Interchange Project held a design open house on November 18<sup>th</sup> at the Best Western Inn, to present the latest designs of the interchange and grade separation to the public. About 200 people attended. The ITD design team is reviewing the comments that were received and will present to KCATT at the December meeting.

Mr. Eric Shanley, Lakes Highway District, reported they are ready for winter operations. He reported they held an open house for their Transportation Plan on October 14<sup>th</sup>, which was well attended. LHD is working with PFHD on the Prairie Avenue Project, which will be a joint overlay project from US-95 to Atlas Ave next year. He reported they are working on three miles of rehab on East Hayden Lake Road. LHD's consultant is working on the Bruner Road/ BNS grade separation project. LHD met with ITD traffic engineers to scope improvements at the Bruner Road/Pope Road intersection, with access to Silverwood. Mr. Shanley reported that LHD is working on a federal grant for the Spirit Lake causeway Bridge. He reported there will be ongoing work through the winter building subdivisions roads.

David Callahan, Kootenai County, reported that in accordance with state law, the county will be updating all of the what used to be called "area city impact agreements", now called "area of impact", with all of county cities. The state law is written that county regulations will prevail, not cities. The county commissioners have decided to follow this law, and are holding an emergency meeting with the cities on December 13<sup>th</sup> to adopt new maps of the areas of impact. A later meeting will be held to adopt agreements. He reported the county is kicking off their comprehensive plan rewrite, that will include the county commissioners, and the parks and waterways board, due to a parks master plan being included. Mr. Callahan announced that he is retiring at the end of January 2026, and that as of the meeting, one candidate had applied and was being interviewed.

Mr. Kevin Jump, City of Rathdrum, reported utility relocation work taking place soon at the Lancaster Ave/ Meyer Ave intersection. He reported they have signed an agreement with the Avista, and are waiting for them to complete the execution of that agreement. Main Street project contractors have completed about a block and a half worth of sidewalk and curb reconstruction work, and are done for the season due to weather. He reported City of Rathdrum Right of Way permits, are no longer being issued for 2025.

Mr. Michael Lenz, Post Falls Highway District, reported the bid opening will be December 2<sup>nd</sup> for the Prairie Pedestrian Underpass. PFHD, partnered with LHD, installed a temporary signal at the intersection of Hayden Ave and Meyer Ave, functioning as of November 10<sup>th</sup>. Mr. Lenz reported the associated highway districts is moving forward with phase two of the standards update contract with JUB. PFHD is preparing for winter maintenance.

Mr. Kevin Howard, Worley Highway District, reported the Greensferry Road guardrail project is physically completed, and waiting on finishing paperwork. Rockford Bay Road/Belgrove Creek structure replacement is complete. Rolling Hills Road Project is buttoned up for the winter. The joint project, with the Coeur d'Alene Tribe, is planning another fish passage for next year, and preparation for soil testing and design is underway for 2026. Cougar Gulch Road project is not complete and is waiting on the contractor and has no additional information at this time.

Mr. Rob Palus, City of Post Falls, reported all of major projects are wrapped up for the year. Post Falls is getting projects ready for bidding for next year's construction. One big project is for deep sewer on Chase Road and Fisher Avenue. There is work planned for Seltice Way between Chase Road and McGuire Road. The city's transportation master plan is near the end, with a workshop planned with city council on December 16<sup>th</sup>. Based upon comments from city council and some adjustments, the city of Post Falls hopes to have a public hearing on adoption in January or February of 2026. Mr. Palus reported the city has stopped permits for any road cuts from occurring for the rest of 2025.

Chad Ingle, Kootenai County, reported they are working on our National Transit Database update for FTA. He reported they received the approval from Board of County Commissioners on five ITD grants. He reported they are currently working on a grant application for 5310, purchase a service for their ring a ride service, which has a grant application due date of December 22<sup>nd</sup>.

Elizabeth Flores, IDEQ, asked ITD if they have a disposal plan for the debris piles created from the I-90 widening project. Robert Beachler and Jerry Wilson stated they weren't sure of the contractor's disposal plan. Ms. Flores suggested that grinding in place would be the preferred method and offered resources from DEQ; she requested ITD reach out to DEQ if they would like to coordinate on a plan, and she is concerned about the environmental impacts of the disposal.

Terry Werner, LTCH, gave an update on the due dates for upcoming grants. Local rural Highway Investment Program due is December 2<sup>nd</sup>. Local Highway Safety Improvement Program due January 29, 2026. Transportation Alternative Program, TAP, is due January 15, 2026. Federal Aid Bridge is due January 22, 2026. Federal Aid, Small Urban, is due January 8, 2026, and have to be into the office by 4pm. Mr. Shanley made a comment thanking LHTAC for their help with the signal that was installed at the Hayden Ave Meyer Ave intersection. LHD used traffic control pay item for their Lancaster roundabout project to help fund the light. The funds will allow the light to stay in place until the Lancaster roundabout it completed in two years.
